#### MINUTES: JUNE 10, 2010

Additions to Agenda under old business: Proof of mailing,

Minutes: The regular meeting minutes from May 20, 2010 were approved as presented on Motion by Darwin, seconded by Vernon. Motion Carried.

Treasurers Report: The Treasurer Shows a balance of \$102,600.82 in the general fund account and a CD worth \$60,000. Presentation of the Bills: Checks #8521 thru 8537 were presented for the General Fund account totaling \$7587.96. No checks were presented for Winchester Sub Special Assessment account. One check was presented for Lackies Birch Haven Special Assessment account in the amount of \$150. Motion was made by Vernon, seconded by Shirley to pay all the bills as presented. Motion carried.

Assessor's Report: The Assessor reported permits issued and sales were presented. Motion by Shirley, Seconded by Vernon to accept as presented. Motion carried. Assessor mentioned that a Resolution for public records viewing must be posted at the township hall for the upcoming Assessors review.

Correspondence: MTA faxes, Commissioners Minutes, Library Minutes, and Sherriff's Stats.

Old Business: Strategic planning Update: no update this month.  
Green Drain Update: no updates unable to contact Drain commissioner.

Township hall new chairs: Motion by Darwin, seconded by Shirley to increase the purchase price of 20 new chairs for town hall to not exceed \$900. Roll call vote all ayes. Motion carried

Resolution for enrollment in internet banking, in order to allow Shirley and Ginger to access the accounts online. Motion by Darwin, seconded by Shirley, Motion Carried.

New Business: Enrollment for the 3- Verizon accounts to be paid by automatically debiting the general account each month. Motion by Darwin, seconded by Vernon. Motion Carried.

Review of Townships Master plan per county zoning administrator, asking for our input on our township master plan. Review and talk more next month.

Public Comment: Jill Huff noted that the town hall soffits and siding are in need of painting or repair. Need to put on next months agenda. (Town hall Repairs and Maintenance)

Board Comment Shirley mentioned that it would be nice if we could get a copy of the planning commission minutes each month, maybe they could email them to us?

April 8 meeting Pam Gilbert asked about the commissioners meeting and whether or not the letter from the township had been sent out and Ginger got proof in writing from Dorothy Burgess (commissioners secretary) that it had been sent out and given to the commissioners.
